**FINDINGS OF FACT, CONCLUSIONS OF LAW, AND ORDER**

A hearing on the above-reference matter was held before the Arkansas Board of Licensure for Professional Engineers and Professional Surveyors ("the Board") on July 9, 2013 at the office of the Board, 623 Woodlane Drive, Little Rock, Arkansas.

Thomas Shaldon Hambuchen (AR-PS #1397 (lapsed), hereinafter "Hambuchen") appeared before the Board representing himself. The Board was represented by Assistant Attorney General Brandon Robinson.

On the basis of the testimony, stipulations of the parties, and other evidence presented during the hearing, the Board makes the following Findings of Fact, Conclusions of Law, and Order.

**FINDINGS OF FACT**

A1. Hambuchen received registration as a Professional Surveyor in Arkansas on April 24, 2000. He did not renew in June 2006 for the 2007 licensing year. As of July 1, 2006, his Professional Surveyor registration was therefore lapsed.

A2. After his Professional Surveyor license was lapsed, Hambuchen performed 149 surveys, for which he sealed, signed, and issued plats to clients.

A3. Hambuchen has requested that his Professional Surveyors registration in Arkansas be restored.

**CONCLUSIONS OF LAW**

C1. Hambuchen's conduct, as outlined in paragraph A1 – A2, constitutes 149 counts of unlicensed practice of surveying, in violation of Arkansas Code Annotated §17-48-201(a)(1).


**ORDER**

O1. Hambuchen is ordered to pay a civil penalty of One Hundred Dollars (\$100.00) for each of the one hundred forty nine (149) counts of the unlicensed practice of surveying in Arkansas, for a total civil penalty of Fourteen Thousand Nine Hundred Dollars (\$14,900.00). The total civil penalty must be received by the Board within fifty (50) days of the service of this Order.

O2. Hambuchen's application for his Professional Surveyor's Registration to be reinstated is hereby denied.

These Findings of Fact, Conclusions of Law, and Order constitute the final written decision of the Board in this matter. This Order may be appealed within thirty (30) days of service, as specified in the Arkansas Administrative Procedures Act, according to provisions of Arkansas Code Annotated §25-15-201, et al.
