DISMISSAL ORDER

The Arkansas Board of Licensure for Professional Engineers and Professional Surveyors (hereinafter "the Board") recorded a complaint on September 26, 2008, alleging that Clyde Scott Lamar (PS #1327, hereinafter "Lamar") violated Arkansas Code Annotated §17-48-303 (entering property without properly announcing or identifying himself).

FINDINGS OF FACT

1. Lamar was retained to survey a parcel adjacent to that of Debra Proto ("Proto"). In order to complete the survey, his crew needed access to and entered upon land owned by Proto and her husband Wenzel Wochos ("Wochos").
2. Before surveying the subject property, Lamar met Wochos and discussed the need for access to the Wochos/Proto property, and apparently permission was granted.
3. Wochos granted permission to access the property, but apparently did not tell Proto.
4. Proto later observed the survey crew and called the local law enforcement authorities, and also confronted the surveyors.

CONCLUSIONS OF LAW


Upon review of the evidence in its possession, the Board finds the conduct by Lamar described in the Findings of Fact does not warrant further investigation or disciplinary action.

The Board, however, is concerned that some surveyors may not be fully aware of their obligations when entering private properties, and therefore asked that the letter notifying Lamar of dismissal of the action explain compliance with Arkansas Code Annotated §17-48-303.

ORDER

Based on these findings, the complaint against Lamar is dismissed without further action by the Board, and a letter of explanation will be issued by the Executive Director.


