

**BEFORE THE ARKANSAS BOARD OF REGISTRATION FOR
PROFESSIONAL ENGINEERS AND LAND SURVEYORS**

IN THE MATTER OF EARL MCKINNEY, PE #5497

On September 11, 2007, the Board of Registration for Professional Engineers and Land Surveyors (hereinafter "Board") held a formal hearing to consider the above-referenced matter. Finding proper notice had been given the Respondent, the Board, from all evidence presented, makes the following Findings of Fact, Conclusions of Law, and Order:

FINDINGS OF FACT

1. Respondent is a professional engineer licensed in the State of Arkansas.
2. Respondent's professional engineering license has been revoked in Kentucky for sealing plans which he did not prepare, or which were not prepared under his supervision, or which were not checked thoroughly by him before sealing.
3. Respondent has not made an answer to an investigation conducted by the Board into his conduct in Arkansas within thirty (30) days.
4. Respondent has sealed ten (10) plans for projects in Arkansas which he did not prepare, or which were not prepared under his supervision, or which were not checked thoroughly before sealing.

CONCLUSIONS OF LAW

1. Respondent's actions described in Findings of Facts #1, #2, #3 and #4 constitute one violation of Arkansas Code Annotated § 17-30-305(5).
2. Respondent's actions described in Findings of Facts #1, #2, #3 and #4 constitute one violation of Arkansas Code Annotated § 17-30-305(6).
3. Respondent's actions described in Findings of Facts #1, #2, #3 and #4 constitute ten(10) violations of Arkansas Code Annotated § 17-30-305(10).

ORDER


1. It is ordered that Respondent pay a \$2,000.00 fine fee for each of the ten (10) violations noted in paragraph #3 of the Conclusions of Law as listed above for a total fine of \$20,000.00.

2. It is further ordered that the Respondent's professional engineering license, license number #5497, is hereby revoked.

IT IS SO ORDERED.

This Order may be appealed within thirty (30) days of service upon the Respondent, as specified in the Arkansas Administrative Procedure Act, Arkansas Code Annotated §25-15-201, et seq.


