The Board has also been involved and is a signatory to the NCEES Resolution of Cooperation. This resolution promotes licensure mobility and reduces barriers for comity applicants. The Board has worked diligently over a 2-year span to promulgate new rules that went into effect September 20, 2020. We will be seeking the approval to promulgate new rules in early 2022 to be in compliance with the new statutes passed by the Arkansas 93rd General Assembly.

This month the Board will be conducting an Arkansas State Specific Survey Exam Workshop with several professionals from around the state to determine future content and verify the State Specific Survey Exam bank questions. Rules of the Board Promote Responsible Licensing

Seeing one of the most challenging years in our rearview mirror, the Board remains focused and committed to protecting the public and state with responsible licensing. Arkansas legislative sessions in 2019 and 2021 have focused on licensure reform. In response to the new legislation, the Board has remained vigilant to promulgate rules to comply with the newly enacted laws. The Rules of the Board can be reviewed and downloaded at www.pels.arkansas.gov.

On September 1, 2020 the Board promulgated rules to be more consistent with national model rules, clarified requirements, eliminated barriers, and incorporated statutory amendments passed during the 92nd Arkansas General Assembly. A summary of the rule changes are as follows: Rules of the Board clarified the conditional approval licensure process for qualified comity and intern licensure applicants; original professional applicants may ask Board permission to take the NCEES Principles and Practice Exam or may apply for licensure after passing the exam; clarified the education requirements for Surveyor Intern and Professional Surveyor applicants; Continuing Professional Competency (CPC) requires Professional Surveyors to obtain at least 2 hours of Standards of Practice No. 1 for Property Boundary Surveys and Plats for each biennial renewal period; the Transformation Act 910 of 2019 changed the administrative duties of the Board; Act 426 and Act 1011 of 2019 amended qualifications for comity applicants and temporary licenses; and Act 820 of 2019 expedites comity licensure for military and their spouses. *continued page 2*

On September 14, 2021 the Board adopted proposed amendments to the Rules of the Board to be in compliance with the 93rd Arkansas General Assembly. The proposed Rules of the Board are pending before the Governor and the legislature.

The amendments are due to Act 135 of 2021 Occupational Licensing of Uniformed Service Members, Act 748 of 2021 Occupational Criminal Background Checks, and Act 725 of 2021 Workforce Expansion. A Public Notice will be issued once the Rules of the Board are finalized and approved for promulgation.

These amendments to the Rules of the Board communicate that the Board recognizes that professional licensure is vital in the mission to protecting the life, health, safety, and welfare of the public.

On a personal note, I would like to express my appreciation for H. James “Jim” Engstrom’s 28 years of service to the board. He was appointed by the Governor in 1993. He was originally licensed as a Professional Engineer No. 3125 on November 5, 1970 and is still Active. Jim was introduced to engineering and the board by his father, Harold J. Engstrom, PE who served on the board from 1957 in the same Engineer Member position until 1968. Jim was elected as President of the Board from 1995-1996, 2003-2004, 2013-2014, and 2020-2021. His service and commitment to the board has been exceptional and unwavering.



REPORT ON DISCIPLINARY ACTIONS

Since June 2020

Case Number 2020- 03 In the Matter of Gilbert Collins v Justin Hall PE 11050

Complaint: Alleged that Hall was practicing as a structural engineer when not qualified to do so.

Resolution: A Hearing was held on June 15, 2021, Hall was found in violation of A.C.A § 17-30-305(a)(1)(B), § 17-30-305(a)(1)(K) and § 17-30-305(a)(1)(D). Hall was found in violation of Board Rules Article 20.A(1), Article 20.A(2), Article 20.B(1) and Article 20.C(1), Hall’s Engineering license and Hall Engineering’s COA were revoked, and Hall was fined a civil penalty of \$7,500. Mr. Hall is currently appealing the Board’s decision in Pulaski County Circuit Court.

Case Number 2020-04 In the Matter of Richardson v Sonny Low PE 11057

Complaint Alleged that Low was unable to provide supporting documentation of the 30 PDH reported during the 2020 renewal.

Resolution: On June 15, 2021, the parties entered into a Consent Agreement with the Board revoking Low’s Engineering license.

Case Number 2020-05 In the Matter of Warner v Lawrence, PS 1552

Complaint: Alleged that Lawrence violated the Arkansas Standards of Practice No 1 for Property Boundary Surveys and Plats.

Resolution: A Hearing was held on September 14, 2021, Lawrence was found in violation of Board Rules Article 14.A. and Article 14.A.4. Lawrence was placed on Probation of 6 months, required to take 6 hours of continuing education, and required to pay a fine of \$1000. Lawrence was also required to submit 20 surveys for review to the Arkansas State Surveyor’s office for compliance review.

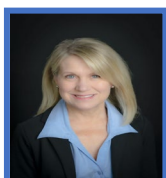

National Council of Examination for Engineers and Surveyors

News and Updates

NCEES develops and scores the Fundamentals of Engineering (FE), Principles and Practice of Engineering (PPE), Fundamentals of Surveying (FS), and Principles and Practice of Surveying (PPS) national exams. The exams are administered in either computer-based testing (CBT) format or paper and pencil format at universities and Pearson VUE tests centers in every state and some international jurisdictions.

CBT administration of all survey exams and most engineering exams is year-round, with a few CBT PPE exams only offered once a year in October. The four (4) year-round testing windows are January–March, April–June, July–September, and October–December.

The last pen-and-paper PPE Civil exams (Construction, Geotechnical, Structural, Transportation, and Water Resources and Environmental) were administered October 21-22, 2021. Future PPE Civil exams will be year-round in CBT format and beginning November 1, 2021 appointment registration will open for the first testing window April 2022. The only remaining paper-in-pencil exam will be the 16-hour Structural Engineering (SE) exam.
