


Arkansas State Board of Licensure


Business being thus concluded the meeting adjourned at 2:35 pm.

SUPERVISION ORDER

Pursuant to the Court's directive of August 31, 2021, the Petitioners and Respondent agree to this Supervision Order.

1. Petitioner Justin W. Hall ("Hall"), when performing work as a professional engineer, will be supervised by an individual who:

A. Is a professional engineer licensed by the Respondent, and whose license is current and active; and

B. Has demonstrated competency in civil engineering or structural engineering; and

C. Has signed a copy of this Supervision Order; and

D. Has been approved by Respondent in accordance with the procedures described in this Supervision Order.

2. Petitioners shall submit to Respondent a copy of this Supervision Order that is signed by the proposed supervisor, along with the proposed supervisor's typed name and credentials as indicated in the below signature line. On Respondent's behalf, Respondent's staff shall review the proposed supervisor's records to ensure the individual meets the requirements described in paragraph 1.A. through D.

3. On Respondent's behalf, Respondent's staff will accept the proposed supervisor in writing if he or she meets the requirements described in paragraph 1.A. through D.

4. Once the Respondent's staff accepts the proposed supervisor in writing, the Respondent's Order of June 18, 2021, shall be stayed in its entirety pending further court or administrative action.

5. Respondent's staff will reject the proposed supervisor in writing if he or she does not meet the requirements described in paragraph 1.A. through D. If the proposed supervisor is rejected, Petitioners may submit another proposed supervisor for consideration in accordance with the above-described requirements and procedure.

6. Once approved, the supervisor shall review all of Petitioners' engineering work product.

7. If the supervisor believes Petitioners' work product complies with Respondent's statutes and rules and with accepted engineering standards, the supervisor shall place on the work product his or her professional engineer seal beside Petitioners' professional seals.

8. Petitioners shall be responsible for remuneration to the supervisor, if any.

9. All work product, after being sealed by the Petitioners and supervisor, shall be sent to the Respondent to ensure compliance with this Supervision Order.


10. Petitioners shall not perform any engineering work that does not conform to the requirements of this Supervision Order.
